The Rector and Churchwardens of the above Parish request the Ratepayers and Electors thereof to meet at La Salle Paroissiale on Monday, 12th May, 2008 at 7.00 p.m. for the following purposes:-

1. To approve the Trésor Accounts which have been duly audited, before the Very Reverend Canon K. Paul Mellor, Dean of Guernsey, or his delegate.
2. To approve the Churchwardens' Parochial Accounts which have been duly audited.
3. To appoint auditors for the Churchwardens' Parochial Accounts for the current year.
4. To hear the Rector nominate his Warden to replace Mr Richard Stanton Taylor whose term of office has expired and who does not seek re-nomination.
5. To elect a People's Warden to replace Mr David John Robilliard whose term of office has expired but who is eligible for re-election.
6. To decide if they are of the opinion to levy the following sums by means of Occupier's Rate:

7. To decide if they are of the opinion of effecting the following extraordinary repairs to the Parish Church, the net cost of which shall be met from the Parish Reserve Fund:

8. To request the Constables to apply to the Royal Court
 - (a) pursuant to sub-section 3(3) of the Parochial Taxation (Reserve Funds) (Guernsey) Law, 1997 for the sum of £29,704 to be drawn from the Parish's Reserve Fund for the purpose set out in paragraph 7 above;
 - (b) for a Remède to levy the sums voted under paragraph 6 above.
