

**THE BANKING SUPERVISION (BAILIWICK OF GUERNSEY) LAW,
1994 (as amended) ("the Banking Law")**

Section 13 of the Banking Law requires the Guernsey Financial Services Commission to publish a list of all institutions holding banking licences issued under section 6 of the Banking Law in January each year.

The licensing or other authorisation of a person (including an incorporated or unincorporated body of persons) by the Guernsey Financial Services Commission does not imply any representation or warranty by the Commission as to the financial soundness of that person or any other matter.

Accordingly, the Commission will not be liable for any loss, damage, cost or expense, whatsoever, incurred by any person as a result of their dealings with any of these institutions.
